## **Bill Payment Promotion Official Rules**

1. <u>How to play</u>: No purchase necessary. Void where prohibited. Contest begins August 6, 2018 and ends September 1, 2018. Each current member who signs up for bill pay, or is already enrolled in bill pay, and sends payment (includes Pay Anyone) to a minimum of one payee prior to September 1, 2018, will get one entry, per account number, (excludes business accounts) into a drawing for Prospera to "pay their bills" up to \$250. (Member will receive a check for \$250.) Each additional sent payment will qualify member for an additional entry. For alternate entry, send an individually postage paid 5"x7" white postcard with your name, address, phone number and email address to: Prospera Credit Union Pay My Bill, 4830 N. Ballard Rd., Appleton, WI 54913. Maximum one postcard per person. Your entry will be added to all other contestants' entries.

Four drawings of \$250 will be held. Drawings will occur August 13, 20, 27 and September 3, 2018 at Prospera Credit Union Ballard Corporate Offices; 4830 N. Ballard Rd., Appleton WI 54913 at 9:00 a.m. Winners will be notified prior to the end of each drawing day. Presence is not required to win. A Prospera Representative will draw one name each week from all of the contestants who participated during the contest period in aggregate. Participants can only win one time; once a participant is deemed an unofficial winner (as defined in Section 4), their name will be eliminated from subsequent drawings.

2. Eligibility: Open only to legal residents of Wisconsin. All winners must be 18 years of age or older to participate. To claim your prize after notification from a Prospera Representative that you have been chosen you must present 2 pieces of ID at the office of Prospera Credit Union 4830 N. Prospera Credit Union will call the person and notify them that they have won a drawing for a \$250 prize. This person is not an "official" winner until proper ID is validated by Prospera Credit Union. Prizes cannot be substituted, converted to cash, assigned, or transferred by winners. Winner must pay taxes; if winner does not or is unable to pay taxes, then a random drawing for another individual will occur. The Credit Union reserves the right to substitute a prize of equal or greater value should the featured prize become unavailable for any reason.

5. **Conditions:** By entering and becoming a winner, participants agree to release, discharge and hold harmless Prospera Credit Union, subsidiary and affiliated companies, licensees and assigns, advertising and promotional agencies and prize suppliers and their respective officers, directors, employees, agents and representatives from all claims, injuries, liabilities and damages arising from or relating to his or her participation in the contest and/or acceptance, use or misuse of any prize.
