

## Community Coloring Contest Benefiting Sexual Assault Crisis Center

- Contest runs from 8/1/17 thru 9/30/17.
- Entries must be received at any Prospera Credit Union branch or Pinot's Palette Appleton no later than 5pm CST on 8/31/17 to qualify for judging.
- Contest entries will be available to purchase for \$5 per entry at any Prospera Credit Union branch or Pinot's Palette Appleton during regular business hours and may be made available at other locations to be determined by the contest sponsors.
- Contest entry can be completed with crayons, pencils, pens, markers, or another similar medium. Mixed media or painted entries that are received will not be judged.
- Open to all individuals (excluding judge(s) and their immediate family) with no geographic restrictions.
- Individuals may purchase and submit an unlimited number of entries.
- Contest will be capped at 1000 purchased entries.
- Entrants will self-select their age group on the entry form. Options are: 0-5, 6-9, 10-13, 14-17, and 18+
- One winner will be chosen from each of five age groups and will receive a \$100 prize each.
- Contest entries will be judged by a local high-school art teacher with 20+ years of art teaching experience.
- Judge(s) and their immediate families are not eligible to enter or win any prizes.
- Judge(s) choosing the age group winners are not affiliated with Prospera Credit Union, Pinot's Palette Appleton, or any other contest sponsors.
- Contest entries to determine the five age group winners will be judged blind, meaning the judge(s) will not see the name or contact info of any entrant before or during judging.
- Contest entries to determine the five age group winners will be judged on accuracy (34%), use of color (33%) and overall creativity (33%).
- Winners of the five age groups will be notified no later than 10/10/17.
- One of the five age group winners will be awarded an additional prize (up to \$500), chosen based on the entry that receives the most community votes (Likes) via Facebook.
- Community Facebook voting will occur from 10/11/17 through 10/13/17.
- In the event of any tie, additional judge(s) will be engaged to score the entries using the criteria listed above, until one winner per age category and/or overall is determined.
- Max value of total prizes awarded is 1/5 total entry fees collected (Example: \$1000 of \$5000).
- All contest entry fees collected (minus funds used to award prizes) will be donated to The Sexual Assault Crisis Center of the Fox Valley.
- If all 1000 entries have not been purchased by 8/31/17, contest dates may be extended to accommodate the sale of additional contest entries.
